Disputes arose between the parties which were referred to the arbitration and the award pronounced on 01/08/2016 was not in favour of the company. Aggrieved by the decision, the company appealed before the Hon'ble Delhi High Court and S M Milkose Limited too approached the same Court seeking performance of the arbitral award.
		After hearing the parties, the Hon'ble High Court, vide judgment dated 27 November 2025, dismissed the Company's appeal and upheld the arbitral award.
