Further to our letter dated October 04, 2023 with respect to pendency of litigations or disputes and in accordance with Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby provide an update in one of the ongoing litigations / disputes matters, as described hereunder:

In the commercial suit of Edelweiss Special Opportunities Fund ("Edelweiss") VS SVL Limited and anr. before the Hon'ble High Court of Bombay, our company was added as a respondent. Edelweiss (the plaintiff) filed a petition before the Hon'ble court to withdraw the suit filed against SVL Limited (one of our Promoters) and our company. The Court allowed petition and the same is disposed as withdrawn vide its Order dated February 16, 2024.
